Schools Health Survey

Dear Parents/Carers

We are writing to inform you about the Schools Health Survey which our school will be taking part in during the spring term, in partnership with Wakefield Council. The survey is conducted every two years across schools in the Wakefield District.

Both the Council and our school consider it very important that the views and experiences of our pupils are listened to on a regular basis in order to ensure that we continue to provide the best service and experience that we can.

The data collected through the survey will be vital for identifying areas that we as a school can improve on, as well as allowing the Council to see on a larger scale the important issues that they need to work on with our children and young people.

The survey will be completely anonymous, so that no one in school or at the Council will be able to identify your child from the responses that they give. Please see the Privacy Notice Microsoft Word - School Health Survey (wakefield.gov.uk) for more information on how and why we use this data.

There will be a range of age appropriate questions covering the following topics:

- Eating and drinking
- Physical activity
- Safety and emotional health
- Free time

The survey will be conducted using an online survey package called SurveyMonkey and will be delivered in school under the supervision of one of our staff. It is designed to take no more than 30 minutes.

If you wish for your child not to take part then please inform their teacher. The pupils will also be given the option to opt-out at the very beginning of the survey.

What personal information do we collect?

The online School Health Survey is carried out as part of the Council's duty to commission and provide health and care services to children and young people. The survey participants are school children in Years 5, 7 and 9. The data is collected directly from the individuals and held by Wakefield Council's Public Health Service.

The categories of information collected will depend on your age group.

As part of the School Health Survey, the Public Health Service may collect and use the following information about you:

- your school;
- your postcode;
- your gender and ethnicity;
- the number of adults in your household;
- your caring responsibilities;
- whether you receive learning or behavioural support at school;
- eating habits and oral health;
- physical activity;
- smoking, drinking alcohol and drug use;
- bullying and safety;
- sexual health;
- wellbeing and sleep;
- social media and internet use;
- use of free time and reading;
- money and gambling; and
- future aspirations.

The data is collected anonymously. Participation is not mandatory and you are free to choose not to provide any of the information we request from you.

Why do we collect your personal information?

We use this information to:

- analyse and understand the health behaviours and needs of the children living in the Wakefield District;
- inform the most suitable health and care services;
- assist schools to understand areas where they can help improve the health and wellbeing of their pupils; and
- support schools to ensure that they offer the lessons and opportunities that most closely align with the needs of their pupils.

Who do we share this information with?

To enable us to provide this service, we may use third party platforms and share your information with our contractors, subject to appropriate contractual and data protection safeguards.

For example, we may use SurveyMonkey to collect the data and we may share the survey data with an external research company in order for them to process and analyse the data on the Council's behalf.

Schools receive a report for their school for benchmarking purposes and reports on the data at a district level are shared with the public. However, these do not identify individual participants.

We will only share the minimum information necessary for the purpose.

What authority does the Council have to collect and use this information?

Wakefield Council relies on the following lawful basis to process your personal data:

UK GDPR Article 6(1)(e) – Public Task: processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Controller.

Where we process your 'special category' data, we also rely on:

Article 9(2)(h) - Health and Social Care: processing is necessary for the provision of health or social care or treatment or the management of health or social care systems and services; meeting Schedule 1, Part 1 of the Data Protection Act 2018 as below:

- (2) Health or social care purposes
- (3) Public health

How long will we keep your data?

We will keep information collected in the survey for the purposes detailed above for a period of 10 years after the survey is conducted, after which time it will be deleted from our systems.

The reason for keeping information for this period of time is to allow for analysis of trends and comparison of data over time.

Your rights and your personal data

Under the UK GDPR you have the following rights:

Right of Access

You have a right of access to the personal information that the Council holds about you, and/or the right to be given a copy of the data undergoing processing.

Right to Rectification

You have the right to request that the Council corrects any personal data if it is found to be inaccurate, incomplete or out of date.

Right to Restriction of Processing

You have the right, where there is a dispute in relation to accuracy or lawfulness of processing of your personal data, to request that a restriction is placed on further processing.

Right to Object to Processing

In certain circumstances, you may have a right to object to the processing of your personal data.

Right of Complaint

Transfer of data outside the UK
